Clear Creek Watershed Planning Process Update:

- Stream Corridor & Floodplain Restoration Planning (I-80/I-380 interchange to the Iowa River) HR Green has been contracted to do this work and is in process of data collection. The resulting planning will be included in the Watershed Management Plan.
- Goal Setting public meetings
 - O August 29th Watershed Hydrology & Resiliency 37 attendees were asked to provide input about flooding and its impact on Rural, Urban, and Socially Vulnerable Populations. Some common themes included raising awareness about flooding and the disproportionate impacts to some groups and using stories and peer to peer interaction to encourage change.
 - o September 19th Water Quality & Public Perception 27 attendees ranked conservation practices to improve water quality in the Clear Creek watershed.
